FOR PUBLIC HEARING

The Director of Parking and Traffic will hold a public hearing on Friday, January 19, 2007, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

**PASSENGER LOADING ZONE, AT ALL TIMES – ESTABLISH (FEE REQUIRED)**

“598” Taylor Street, east side, from 15 feet to 33 feet south of Post Street (18-foot zone).

*Note: Existing metered loading zone will be relocated to meter 528 (22-foot zone, 7am to 6pm, Monday thru Friday)*

**PART-TIME PASSENGER LOADING ZONE, 10AM TO 3PM MONDAY THRU FRIDAY, 10AM TO 6PM SATURDAY, AND 12NOON TO 5PM SUNDAY – ESTABLISH (FEE REQUIRED)**

685 Mission Street, south side, from 121 feet to 165 feet east of 3rd Street (44-foot zone).

*Note: Established as a part-time passenger loading zone with signs and no meters.*

**PASSENGER LOADING ZONE, DURING BUSINESS HOURS – ESTABLISH (FEE REQUIRED)**

100 Bush Street, north side, from 168 feet to 210 feet east of 8<sup>th</sup> Street (42-foot zone at parking meter no.'s 660 and 662).

**TOUR BUS ZONE, 8AM TO 9PM, EVERYDAY – ESTABLISH (FEE REQUIRED)**

2800 and 2898 Leavenworth Street, east side, from 21 feet to 112 feet south of Jefferson Street (91-foot zone replacing existing metered 6-wheel truck loading zone at at parking meters no.'s 2818, 2820, 2822, 2824 to be replaced from 13 feet to 73 feet north of Beach Street).

2655 Bush Street, from 10 feet to 32 feet west of Divisadero Street (22-foot zone at parking meters no.'s 520 and 522).

**PASSENGER LOADING ZONE, – REVOKE**

1001 Grant Street, from 8 to 29 feet north of Jackson Street (21-foot zone)

**YELLOW ZONE, 7AM TO 6PM, MONDAY THRU SATURDAY – REVOKE**

123 South Van Ness Avenue, east side, from 144 feet to 166 feet south of 12<sup>th</sup> Street (22-foot zone).

**PART-TIME PASSENGER LOADING ZONE, 5:30PM TO 11PM MONDAY THRU SATURDAY – REVOKE**

550 Washington Street, north side (42-foot zone at parking meters no.'s 520 and 522).
