

SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY Order # 5060 FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, February 15, 2013, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

1. REVOKE – PART-TIME PASSENGER LOADING ZONE, 8 AM TO 10 AM AND 3 PM TO 6 PM, MONDAY THROUGH FRIDAY

818 Illinois Street, west side, from 0 feet to 83 feet south of north driveway (83-foot zone)*

2. <u>ESTABLISH – NO TURN ON RED</u>

Oak Street at Broderick Street

3. <u>ESTABLISH – NO PARKING ANYTIME EXCEPT BICYCLES</u>

Florida Street, west side, from 13 feet to 22 feet north of 20th Street (9-foot wide by 15-foot long marked space)*

4. <u>ESTABLISH – NO PARKING ANYTIME EXCEPT BICYCLES</u>

Laguna Street, west side, from 2 feet to 24 feet north of Page Street (22-foot zone)*

5. <u>ESTABLISH – NO PARKING ANYTIME EXCEPT BICYCLES</u>

Valencia Street, west side, from 164 feet to 184 feet south of 25th Street (20-foot zone, within marked and metered space #1418)*

6. <u>ESTABLISH – RED ZONE</u>

Taraval Street, north side, from east crosswalk (at Wawona Street intersection) to 20 feet easterly*

7. ESTABLISH – UNMETERED MOTORCYCLE PARKING

20th Street, north side, from 105.5 feet to 108.5 feet west of Valencia Street (3-foot zone beginning at the driveway of 3616 and 3618 20th Street)*

8. ESTABLISH – TOW-AWAY NO STOPPING, 7 AM TO 6 PM EXCEPT SUNDAY

Faxon Avenue, west side, from Ocean Avenue to 95 feet northerly (Upgrades existing no parking regulation with same effective hours)

9. ESTABLISH – STOP SIGNS

Stopping eastbound and westbound Bay Street at Baker Street, the stems of these two "T" intersection

10. ESTABLISH – RED ZONE

Fulton Street, north side, from 15th Avenue to 31.5 feet easterly

11. <u>ESTABLISH – STOP SIGNS</u>

Stopping 17th Street at Missouri Street, making this intersection an all-way STOP

12. <u>ESTABLISH – TOW-AWAY NO PARKING 12:01 AM – 6 AM EVERYDAY</u>

Quesada Avenue, north side, from 3rd Street to 130 feet easterly Quesada Avenue, south side, from 3rd Street to 113 feet easterly

13(a) ESTABLISH – 8-FOOT WIDE SIDEWALK EXTENSION

Noe Street, east side, from Market Street to 8 feet southerly*

13(b) ESTABLISH – 5-FOOT WIDE SIDEWALK EXTENSION

16th Street, south side, from Market Street to 4 feet easterly*

14(a) RESCIND - TOW-AWAY, NO STOPPING, 7 AM TO 6 PM, MONDAY TO FRIDAY ESTABLISH - TOW-AWAY, NO STOPPING, 6 AM TO 10 AM AND 3 PM TO 7 PM, MONDAY THROUGH FRIDAY

ESTABLISH – METERED PARKING, MONDAY THROUGH SUNDAY, AREA 1 OPERATION TIMES (\$3.50 / HOUR)

Bush Street, north side, between Kearny and Sansome Streets

14(b) <u>ESTABLISH – COMMERCIAL (YELLOW) METERED PARKING, ONE HOUR TIME</u> <u>LIMIT, 10 AM TO 3 PM, MONDAY THROUGH FRIDAY</u>

Bush Street, north side, between Belden Street and Treasury Lane*

14(c) ESTABLISH - NO PARKING ANYTIME

Bush Street, north side, between Kearny and Belden Streets

14(d) ESTABLISH – ONE-WAY WESTBOUND

Augusta Street, from Silver Avenue to Waterville Street

14(e) RESCIND - STOP SIGN

Augusta Street, eastbound, at Silver Avenue

14(f) ESTABLISH – STOP SIGN

Waterville, southbound, at Silver Avenue

14(g) ESTABLISH – NO PARKING ANYTIME

Augusta Street, south side, from Waterville Street to Silver Avenue Waterville Street, east side, from Silver Avenue to Augusta Street

14(h) <u>ESTABLISH – SIDEWALK WIDENING AND NO PARKING ANYTIME (FOR A 6-FOOT WIDE CURB BULB-OUT)</u>

Augusta Street, north side, from Silver Avenue to 18 feet westerly*

14(i) ESTABLISH – CROSSWALK

Augusta and Waterville intersection, eastside crossing

15(a) ESTABLISH - NO PARKING ANYTIME ESTABLISH - SIDEWALK WIDENING

Claremont Boulevard, east side, from Granville Way to 18 feet northerly (18-foot zone for 6-foot wide bulb-out)*

Granville Way, north side, from Claremont Boulevard to 18 feet easterly (18-foot zone for 6-foot wide bulb-out)*

Claremont Boulevard, west side, from 13 feet to 24 feet north of Granville Way and from Granville Way to 16 feet southerly (40-foot zone for 6-foot wide bulb-out)*

Claremont Boulevard and Granville Way, southeast corner, reducing corner radius from 32 feet to 15 feet

15(b) ESTABLISH - TRAFFIC ISLANDS

Claremont Boulevard and Allston Way, north and south crosswalks* Relocate existing traffic island on Claremont Boulevard at Granville Way, south crosswalk to 13 feet north*

Claremont Boulevard at Dewey Circle crosswalk* Kensington Way at Dewey Circle crosswalk* Montalvo Avenue at Dewey Circle crosswalk*

The purpose of traffic engineering hearings for the San Francisco Municipal Transportation Agency (SFMTA) Sustainable Streets Division is for residents to express their concerns regarding the posted parking and traffic changes affecting their streets. At the hearing, the public hearing officer, after reviewing the items and listening to residents, will make a decision as to whether the items are approved or not. Any interested parties are encouraged to attend.
