BRIEF DESCRIPTION:

Approving the San Francisco Municipal Transportation Agency Fiscal Year (FY) 2012-2013 and FY 2013-2014 Operating Budget, totaling \$821.0 million and \$840.5 million respectively for each year, including authorizing changes to various fines, fees, fares, rates and charges as summarized in Exhibits 1-5, approving Sunday parking meter enforcement between the hours of 12 pm - 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, and approving the installation of additional parking meters.

SUMMARY:

- Under the City Charter, the SFMTA must submit an Operating Budget for two fiscal years to the Mayor and the Board of Supervisors by May 1st of each even numbered year.
- On November 14, 2011, February 21, 2012 and March 6, 2102, the SFMTA Board of Directors reviewed the Proposed Operating Budget for FY 2013 and FY 2013 including initial projected deficits of \$34.1 million and \$45.6 million respectively and possible options to balance these deficits.
- SFMTA staff held Budget Town Hall meetings on March 3, March 8, March 14, March 15, and March 21, 2012.
- Pursuant to Charter Section 16.112 and the Rules of Order of the Board of Directors, advertisements were placed in the City's official newspaper to provide notice of the public hearings. In compliance with these requirements, the advertisements ran in the San Francisco Chronicle beginning on February 15, 2012 for the March 6, 2012 hearing; and beginning on March 12, 2012 for the April 3, 2012 hearing.

PURPOSE

Approving the San Francisco Municipal Transportation Agency Fiscal Year (FY) 2012-2013 and FY 2013-2014 Operating Budget, totaling \$821.0 million and \$840.5 million respectively for each year, including authorizing changes to various fines, fees, fares, rates and charges after holding a public hearing as summarized in Exhibits 1-5, approving Sunday parking meter enforcement between the hours of 12 pm - 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, and approving the installation of additional parking meters.

GOAL

Approval of the proposed resolution will support:

- Goal 1: Create a safer transportation experience for everyone.
- Goal 2: Make transit, walking, bicycling, taxi, ridesharing, and carsharing the preferred means of travel.
- Goal 3: Improve the environment and quality of life in San Francisco.
- Goal 4: Create a workplace that delivers outstanding service

DESCRIPTION

The SFMTA is preparing a two-year balanced Operating Budget for FY 2013 and FY 2014 for submittal by May 1, 2012 as required by Charter section 8A.106. On February 21, 2012, the SFMTA Board of Directors reviewed the Projected Budget for FY 2013 and FY 2014 that included a \$19.6 million deficit for FY 2013 and a \$33.6 million deficit for FY 2014 based on projections as of mid-February 2012, down from the previous projections as of mid-November 2011 of \$34.1 and \$45.6, respectively. Solutions to balance the operating budget in the first year would carryover and resolve the second year deficit.

Since the February 21, 2012 Board meeting, several steps have been taken to balance the Proposed FY 2013 and FY 2014 Operating Budget summarized in Table 2 below.

The Proposed Operating Budget for FY 2013 and FY 2014 is summarized below:

Published Notice

Charter Section 16.112 requires published notice and hearing before the SFMTA may institute or change any fare, fee, schedule of rates or charges which affect the public. The Board's Rules of Order require that the advertisement run for at least five days and not less than fifteen days prior to the public hearing. In compliance with this requirement, an advertisement ran in the San Francisco Chronicle for a five-day period beginning on February 15, 2012 for the March 6, 2012 hearing; on March 12, 2012 for the April 3, 2012 hearing.

Environmental Clearance

Modifications to fees, fares, rates and charges are subject to the California Environmental Quality Act (CEQA). Pursuant to the City Charter, revenue from parking related fees, rates and charges support transit service.

CEQA provides a statutory exemption from environmental review for the establishment, modification, structuring, restructuring or approval of rates, tolls, and other charges pursuant to California Public Resources Code section 21080(b)(8) and CEQA implementing guidelines, Title 14 of the California Code of Regulations section 15273 if these rates, tolls, and other charges will be used to meet operating expenses, including employee wage rates and fringe benefits, or purchase or lease supplies, equipment, or materials.

The SFMTA has received two environmental review determinations that the proposed modifications to fines, fees, fares, rates and charges included in the FY 2013 and FY 2014 Operating Budget, as itemized in Exhibits 1-5, including Sunday parking meter enforcement between the hours of 12 pm - 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, are statutorily exempt from environmental review under the above cited provisions.

In addition, the Planning Department issued a Class 3 categorical exemption on April 20, 2010, pursuant to CEQA implementing guidelines, Title 14 of the California Code of Regulations ("CEQA Guidelines") section 15303, which provides a categorical exemption from environmental review for the construction of small structures, in response to the SFMTA's proposed installation of additional parking meters throughout the City. At this time, the SFMTA is requesting approval to now install a portion of the meters that were included in the Planning Department's April 20, 2010, environmental review determination.

Title VI Analysis

Pursuant to the requirements contained in the Federal Transit Administration's (FTA) Circular 4702.1A, "Title VI and Title VI-Dependent Guidelines for FTA Recipients," Chapter V part 4, the SFMTA has conducted an evaluation of the proposed fare changes to Municipal Railway passes, passports, stickers, and fares as described in this document and does not foresee discriminatory impacts resulting from any of the proposed fare changes. With regard to the proposed changes to either reduce or eliminate fares for all youth or low-income youth, because accessing the decreased or free fares requires the use of a Clipper card, there could be a disparate impact for those youth who otherwise pay with cash. However, this potential impact can be mitigated by the distribution of free Clipper cards to affected youth who typically otherwise pay with cash.

Certification That SFMTA Budget Are Adequate

City Charter Section 8A.106 (b) requires the SFMTA to certify that the budget is adequate in all respects to make substantial progress towards meeting the performance standards established pursuant to Section 8A.103 for the fiscal year covered by the budget. The budget resolution includes that certification.

Technical and Clerical Corrections

The budget resolution authorizes the Director of Transportation to make any necessary technical and clerical corrections to the approved SFMTA budget and to allocate additional revenues and/or City and County discretionary revenues in order to fund additional adjustments to the operating budget. The Director of Transportation must return to the SFMTA Board of Directors for approval of technical or clerical corrections that, in aggregate, exceed a five percent increase of the total FY 2013 and FY 2014 Operating Budget.

Proposition J Certifications

Section 10.104.15 of the San Francisco Charter allows City departments to contract for services where such services can be practically performed under private contract at a lesser cost than

similar work performed by City employees, as determined by the Controller. The Board of Supervisors requested that all Proposition J certifications be included as part of the SFMTA's budget. In response to the Board of Supervisors' request, six Proposition J certifications are being reviewed by the City Controller and certifications are available upon request.

The SFMTA's Proposition J certifications include:

- Services For A Parking Citation Processing And Collection System;
- o Facility Security Services;
- o Paratransit Services;
- o Low Level Platform Maintenance Services;
- o Vehicle Towing, Storage And Disposal Services; (pending Controller's approval); and
- o Parking Meter Collection And Coin Counting Services (pending Controller's approval)

The Controller's certifications for FY 2013 and FY 2014 declaring that all six of the SFMTA's contracts can be practically performed by private contractors at a lesser cost than to provide the same services with City employees are pending.

ALTERNATIVES CONSIDERED

The SFMTA Board considered various options at the February 21, 2012 and March 6, 2012 Board meetings including those summarized in Exhibits 1-5 which are part of the FY 2013 and FY 2014 Operating Budget.

OTHER APPROVALS RECEIVED OR STILL REOUIRED

The SFMTA Board must approve a balanced Operating Budget for FY 2013 and FY2014 for submittal to the Mayor and the Board of Supervisors by May 1, 2012.

The City Attorney has reviewed this calendar item.

FUNDING IMPACT

The Proposed FY 2013 and FY 2014 Operating Budget, once approved, will provide \$821.0 million and \$840.5 million respectively to the Agency.

RECOMMENDATION

Approve the proposed FY 2013 and FY 2014 Operating Budget in the amount of \$821.0 million and \$840.5 million respectively, including authorizing changes to various fines, fees, fares, rates, and charges, parking meter enforcement on Sundays between the hours of 12 pm to 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, and the installation of additional parking meters.

WHEREAS, The FY 2013 and FY 2014 Operating Budget for the SFMTA is being prepared in accordance with the City Charter Section 8A.106 and is \$821.0 million for FY 2013 and \$840.5 million for FY 2014; and

WHEREAS, Charter Section 8A.106(b) requires the SFMTA to certify that the budget is adequate in all respects to make substantial progress towards meeting the performance standards established pursuant to Section 8A.103 for the fiscal year covered by the budget; and

WHEREAS, The SFMTA's FY 2013 and FY 2014 Operating Budget include the revenue and expenditure adjustments to reflect the Municipal Railway fare change for free service on New Year's Eve 2014 and 2015; and

WHEREAS, Authorizing the SFMTA's Director of Transportation to implement short-term experimental fares enables the SFMTA to respond effectively to community requests; and

WHEREAS, The SFMTA is proposing to change various fines, fees, fares, rates and charges, as itemized in Exhibits 1-5 including Municipal Railway transit passes, passports, stickers and fares, Candlestick Park Express and Special Event service fares, transit fare evasion/passenger conduct fines, neighborhood and other parking permit fees, temporary street closure permit fees, color curb fees, special traffic permit fees, community service processing fees, taxi service regulatory fees, traffic permit fees and penalties, boot removal fees, auto tow and storage fees, cable car/historic street car rental fee, special collection fees, parking meter use fees, temporary exclusive use of parking meter fees, Transportation Code and Vehicle Code penalties, parklet installation fee, and parking citation fines; and

WHEREAS, Revisions to Division II of the Transportation Code to increase parking citation late payment penalties, special collections fees, boot removal fees, various parking citation, Transportation Code, and Vehicle Code penalties, color curb painting fees, towing and storage administrative fees, the motor vehicles for hire penalty schedule, the request for community service processing fee, the parking meter use fee, the special traffic permit fee, the temporary exclusive use of parking meter fee, residential area and other parking permit fees, and temporary street closure permit fees, and add Section 313 to establish a parklet installation fee are attached in Section II; and

WHEREAS, The SFMTA is proposing to enforce parking meters on Sundays between the hours of 12 pm and 6 pm and establish a four hour time limit for parking at a meter on Sundays, and install up to 1,000 new additional parking meters; and

WHEREAS, The anticipated revenues from the changes in various fees, fares, rates and charges itemized in Exhibits 1-5 will be used to meet SFMTA operating expenses, including employee wages and benefits or to purchase and lease essential supplies, equipment and materials as documented in the SFMTA's FY2013 and FY2014 proposed Operating Budget; and

WHEREAS, Pursuant to Section 10 of the SFMTA Rules of Order and Charter Section 16.112, duly noticed public hearings concerning fines, fees, fares, rates and charges were conducted on March 6, 2012 and April 3, 2012; and

WHEREAS, It has been determined that the changes in various fines, fees, fares, rates and charges, as itemized in Exhibits 1-5, including Sunday parking meter enforcement between the hours of 12 pm – 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, are statutorily exempt from environmental review under California Public Resources Code section 21080(b)(8) and CEQA implementing guidelines, Title 14 of the California Code of Regulations section 15273 because the anticipated revenues will be used to meet SFMTA operating expenses, including employee wage rates and fringe benefits, or to purchase or lease supplies, equipment, or materials as documented in the SFMTA's FY2013 and FY2014 proposed Operating Budget; and

WHEREAS, It has been determined that the proposed construction and installation of the proposed new parking meters is categorically exempt from environmental review pursuant to CEQA Guidelines section 15303, which provides a categorical exemption from environmental review for the construction of small structures; and

WHEREAS, These CEQA determinations are on file with the Secretary to the SFMTA Board of Directors and are incorporated herein by this reference; and

WHEREAS, Section 10.104.15 of the San Francisco Charter allows City departments to contract for services where such services can be practically performed under private contract at a lesser cost than similar work performed by employees of the City and County, as determined by the Controller and approved annually by the Board of Supervisors; and,

WHEREAS, The SFMTA has ongoing contracts for parking citation processing and collection; facility security services; paratransit services; parking meter collection and coin counting services; low-level platform maintenance services; and vehicle towing, storage and disposal services ("miscellaneous services"); and,

WHEREAS, The Controller has determined that for FY 2013 and FY 2014, the miscellaneous services can be practically performed by private contractors at a lesser cost than if they were performed by employees of the City; now, therefore, be it

RESOLVED, That the SFMTA Board of Directors approves the SFMTA's FY 2013 and FY 2014 Operating Budget in the amounts of \$821.0 million and \$840.5 million; and be it further

RESOLVED, That in accordance with the requirements of Charter Section 8A.106(b), the SFMTA certifies that the FY 2013 and FY 2014 Operating Budget is adequate in making substantial progress towards meeting the performance standards established pursuant to Section 8A.103 for 2012-2013 and 2013-2014; and be it further

RESOLVED, That the SFMTA Board approves changes in various fines, fees, fares, rates and charges, as itemized in Exhibits 1-5 including Municipal Railway transit passes, passports, stickers and fares, Candlestick Park Express and Special Event service fares, transit fare evasion/passenger conduct fines, neighborhood and other parking permit fees, temporary street closure permit fees, color curb fees, special traffic permit fees, community service processing fees, taxi service regulatory fees, traffic permit fees and penalties, boot removal fees, auto tow and storage fees, cable car/historic street car rental fee, special collection fees, parking meter use fees, temporary exclusive use of parking meter fees, Transportation Code and Vehicle Code penalties, and parking citation fines, and establishing a parklet installation fee; and be it further

RESOLVED, That the SFMTA Board approves the revisions to Division II of the Transportation Code to increase parking citation late payment penalties, special collections fees, boot removal fees, various parking citation, Transportation Code, and Vehicle Code penalties, color curb painting fees, towing and storage administrative fees, the motor vehicles for hire penalty schedule, the request for

community service processing fee, the parking meter use fee, the special traffic permit fee, the temporary exclusive use of parking meter fee, residential area and other parking permit fees, and temporary street closure permit fees, and add Section 313 to establish a parklet installation fee as attached in Section II; and be it further

RESOLVED, That the SFMTA Board approves enforcement of parking meters on Sundays between the hours of 12 pm and 6 pm and establishing a four-hour time limit for parking at a meter on Sundays, and the installation of up to 1,000 additional parking meters; and be it further

RESOLVED, That the SFMTA Board approves a waiver of fares on New Year's Eve 2013, between 8 PM on December 31, 2012 and 6 a.m. January 1, 2013 and on New Year's Eve 2014, between 8 PM on December 31, 2013 and 6 a.m. January 1, 2014; and be it further

RESOLVED, That the SFMTA Director of Transportation is hereby authorized to implement short-term experimental fares; and be it further

RESOLVED, That the SFMTA Board of Directors concurs with the Controller's certification that parking citation processing and collection; facility security services; paratransit services; parking meter collection and coin counting services; low-level platform maintenance services; and vehicle towing, storage and disposal services can be practically performed by private contractors at a lesser cost than to provide the same services with City employees; and be it further

RESOLVED, That the SFMTA Board will continue to work diligently with the Board of Supervisors and the Mayor's Office to develop new sources of funding for SFMTA operations pursuant to Charter Section 8A.109; and be it further

RESOLVED, That the Director of Transportation is hereby authorized to make any necessary technical and clerical corrections to the approved budget of the SFMTA and to allocate additional revenues and/or City and County discretionary revenues in order to fund additional adjustments to the operating budget, provided that the Director of Transportation shall return to the SFMTA Board of Directors for approval of technical or clerical corrections that, in aggregate, exceed a five percent increase of the total SFMTA Budget.

EXHIBIT 2 Cost Recovery Fees

All fees in this exhibit are calculated based cost recovery methodology for SFMTA costs except for fees associated with automobile towing and storage which, in addition to SFMTA cost recovery fees, include the towing and storage fees charge by the SFMTA's towing contractor.

Neighborhood Parking Permit Program (including Residential, Visitor, Business and Commercial, and Contractor Parking Permit Fees):

The Neighborhood Parking Program was established in 1976 to provide greater parking availability for City residents and merchants by discouraging long-term parking by non-residents or commuters. Presently there are 27 residential parking permit areas in the City. The current fee for a standard annual permit is at \$100.00. These parking permit fees are a cost recovery fee and proposed increases will offset the actual costs for enforcement and other expenses associated with the administration of the Neighborhood Parking Program. The SFMTA is proposing to increase the fees for residential and contractor permits for FY 2013 and FY 2014 as described below.

Color Curb Program:

Residents, organizations, and business owners apply for various colored curb parking designations as authorized by the California Vehicle Code. These zones include white zones (passenger loading and unloading), green zones (10-minute parking), red zones (no parking), and yellow zones (freight loading and unloading). The program's costs are funded by fees charged to the requestors. Yellow zones have historically not had a fee associated with them. Yellow zones are often initiated by Parking and Traffic to reduce double parking which may delay Muni buses and LRV trains. The yellow zones generally serve the entire block and not a specific business. Some taxi and tour bus zones are assessed white zone fees when the zone serves a hotel or identifiable commercial entity or beneficiary

Special Traffic Permits: A Special Traffic Permit is required for any work that obstructs traffic on any street or sidewalk area due to construction, excavation, or other activity. A contractor must apply for a permit at least two business days prior to commencing work. The current permit fee is \$176 for processing and \$36 per day for the duration of the project. To address situations when permit applications are submitted with less than two business days prior to the work, a late fee of \$201 is currently assessed. The proposed increase in the special traffic permit fees are estimated to offset the cost of enforcement and other expenses associated with the administration of the program.

SECTION II: TRANSPORTATION CODE LEGISLATION

Resolution amending San Francisco Transportation Code, Division II, by amending Sections 301, 302, 303, 304, 305, 310, 311, 312, and 902 to increase parking citation late payment penalties, the special collections fee, boot removal fees, various parking citation, Transportation Code, and Vehicle Code penalties, color curb painting fees, towing and storage administrative fees, the motor vehicles for hire penalty schedule, the request for community service processing fee, parking meter use fee, the special traffic permit fee, the temporary exclusive use of parking meter fee, residential area and other parking permit fees, and temporary street closure permit fees, and to add Section 313 to establish a parklet installation fee.

NOTE: Additions are <u>single-underline Times New Roman</u>; deletions are <u>strike-through Times New Roman</u>.

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Articles 300 and 900 of Division II of the Transportation Code is hereby amended by amending Sections 301, 302, 303, 304, 305, 310, 311, and 312 to read as follows:

SEC 301. LATE PAYMENT; SPECIAL COLLECTIONS AND BOOT REMOVAL FEE.

Except as otherwise specified in this Code, the SFMTA may charge the following penalties and fees to persons to whom civil citations have been issued or to owners of cited vehicles for failure to either pay the citations or to contest the underlying citations by the due date affixed to the notice of violation:

- (a) The penalty for failure to pay a citation penalty or contest the underlying citation by the first due date affixed to the notice of violation shall be \$25.0026.25 effective July 1, 2012, and \$27.25 effective July 1, 2013.
- (b) The penalty for failure to pay a citation penalty or contest the underlying citation by the second due date affixed to the notice of violation shall be \$35.0036.75 effective July 1,

2012, and \$38.25 effective July 1, 2013.

- (c) The fee to reimburse the City for collection costs incurred as a result of a citation that is not either contested or paid by the first due date affixed to the notice of violation shall be \$40.000042.00 effective July 1, 2012, and \$44.00 effective July 1, 2013.
- (d) A fee to reimburse the City for the costs of removing boots from scofflaw vehicles in the amount of \$280.00300.00 effective July 1, 2012, and \$312.00 effective July 1, 2013.

SEC. 302. TRANSPORTATION CODE PENALTY SCHEDULE.

- (b) <u>Exemptions from White Zone Fees.</u> The following entities shall be exempt from paying white zone fees so long as such entities are primarily conducting nonprofit activities at the location of the white zone:
 - (1) Government buildings open to the public;
- (2) Buildings occupied by private nonprofit organizations whose exclusive function is serving senior citizens and persons with disabilities; and
- (3) Private nonprofit educational institutions whose exclusive function is providing education to students in any grade from kindergarten through eighth grade.
- (c) Nothing in this Section is intended to limit the SFMTA's ability on its own initiative.

SEC. 305. TOWING AND STORAGE ADMINISTRATIVE FEES.

The SFMTA shall charge the owner of a towed vehicle a fee in the amount of \$186.50243.00 effective July 1, 2012, and \$254.00 effective July 1, 2013, to reimburse the City for administrative to install color curb markings costs related to the removal, impound, or release of vehicles towed from the public right-of-way. In addition, the SFMTA shall charge the vehicle owner a fee to reimburse the City for administrative costs related to the storage of such towed vehicles in the amount of \$2.002.60 effective July 1, 2012, and \$2.70 effective July 1, 2013, for the first day of storage (24 hours or less), and \$2.252.95 effective July 1, 2012, and \$3.05 effective July 1, 2013 for each day, or part thereof, that the vehicle remains in storage after the first 24 hours. The administrative fees imposed pursuant to this Section shall be in addition to the fee charged by a tow car operator to the owner of a towed vehicle for the costs of towing and storing the vehicle. The administrative fees imposed pursuant to

this Section shall not be taken into account in determining the maximum fee that may lawfully be charged by the tow car operator to the owner of a removed vehicle, nor shall the administrative fees imposed pursuant to this Section be taken into account in determining whether a fee charged by the tow car operator to the owner of a removed vehicle is excessive as a matter of law.

SEC. 311. REQUEST FOR COMMUNITY SERVICE PROCESSING FEE.

A fee to reimburse the SFMTA for costs associated with processing requests for community service in-lieu of payment for parking or transit violation citations. The amount for this fee shall be \$15.0037.50 effective July 1, 2012 and \$39.25 effective July 1, 2013.

SEC. 312. PARKING METER USE FEE.

A fee charged for rendering Parking meters inaccessible to parking due to activities that are non-construction related and do not require either a Temporary Exclusive Use Parking Meter Permit issued pursuant to Section 904 of this Code, or a Temporary Use or Occupancy of Public Streets permit issued pursuant to Article 6 of this Code. The fee shall

be \$5.00\\$6.00 per day per metered Parking space. The fee shall be \$7.00 per day per metered Parking space effective July 1, 2013.

Section 2. Article 900 Division II of the Transportation Code is hereby amended by repealing Table 902(d) and adding a new Table 902(d) to read as follows:

SEC. 902. GENERAL PERMIT CONDITIONS.

The following general provisions apply to all permits issued under this Article.

- (a) Application and Renewal. Permit applications must be submitted on a form supplied by the SFMTA. All required application fees must be paid and all permit requirements satisfied before a permit may be issued. The SFMTA may require any information of the applicant which it deems necessary to carry out the purposes of this Article. Permits may be renewed annually in compliance with any renewal procedures established by the SFMTA.
- (b) <u>Display of Permit.</u> Permittees must maintain the permit at the site of the permitted activity and available for inspection in accordance with any requirements for permit display as may be established by the SFMTA, and shall make all permits available for inspection upon request by an employee of the Police Department or SFMTA.
- (c) <u>Prior Payments Required.</u> No permit shall be issued or renewed until the applicant has paid all permit fees that are due to the SFMTA. No permit shall be issued to any applicant who is responsible for payment of one or more delinquent citations for violation of any provision of this Code or the Vehicle Code until all fines and fees associated with the citation are paid in full.

- (e) <u>Indemnification.</u> The permit application for Special Traffic Permits issued pursuant to Section 903, and permits for the Temporary and Exclusive Use of Parking Meters issued pursuant to Section 904, shall require the applicant to acknowledge that the Permittee, by acceptance of the permit, agrees to indemnify and hold the City and County of San Francisco, its departments, commissions, boards, officers, employees and agents ("Indemnitees") harmless from and against any and all claims, demands, actions or causes of action which may be made against the Indemnitees for the recovery of damages for the injury to or death of any person or persons or for the damage to any property resulting directly or indirectly from the activity authorized by the permit regardless of the negligence of the Indemnitees.
- (f) <u>Rules and Regulations.</u> Compliance with all applicable rules and regulations and with all permit conditions shall be a material condition for the issuance or renewal of a permit.
- (g) <u>Permit Revocation.</u> The Director of Transportation is authorized to revoke the permit of any Permittee found to be in violation of this Article and, upon written notice of revocation, the Permittee shall surrender such permit in accordance with the instructions in

the notice of revocation.

Section 3. Article 300 Division II of the Transportation Code is hereby amended by adding Section 313 to read as follows:

SEC. 313. – PARKLET INSTALLATION FEE.

A fee to reimburse the SFMTA for costs associated with the removal of a parking space and installation of a parklet including staff time for planning, design, and engineering analysis, and the physical removal and relocation of any parking meter. The amount for this fee shall be \$1,269.00 effective July 1, 2012, and \$1,297.00 effective July 1, 2013. If the installation of a parklet exceeds two parking spaces, the fee shall be an additional \$600 per additional parking space.

Section 4. This Resolution shall become operative on July 1, 2012.
