

# Operators, Transit Line Terminals, Restrooms, and "Gaps"

- 2,200 Transit Operators, including 600 Female Operators
- 76 transit lines with 146 terminals
  - Now: 14 Portables in 12 locations, 16 Licenses with businesses, 21 Permanent Operator Restrooms, other SFMTA yards and facilities for Operators to use
- 57 terminals with "gaps"
  - 43 with no facility
  - 14 with temporary Portables to be replaced
- **Challenge** how to fill the "gaps" Licenses, Prefabs, Permanent; alternative: move terminals to other locations
- The "gaps" prioritized into 6 SF areas: visit businesses re: License to provide restrooms for Operators

# **Operator Convenience Station Project:** (Prefabs): 7 in Process, More Pending

- Proposal install in 3 Phases
  - (1) 7 Prefab locations 6 in DPW, CEQA, Arts Commission process + 1 in Presidio National Park process
  - (2) 3 other Portables
  - (3) Future Locations where "gaps"
- 7 Prefabs 5/30/12 4 bids from 2 vendors, 1 acceptable; \$357,539 delivered
- Revised Major Encroachment Permit application filed
- Arts Commission 1<sup>st</sup> hearing 5/21/12, 1<sup>st</sup> re-hearing 6/18/12, 2<sup>nd</sup> hearing 7/16/12
- Schedule: Estimate 5 months for CCSF Planning (General Plan referral, CEQA), Arts Commission (3 hearings), DPW, SFMTA Board, BOS + 1 month for installation = 6 months, inc. public hearings

# 25<sup>th</sup> St. and Potrero (33 Line)

- Potrero Market restroom too small, no door; owner not interested in Prefab in parking lot – no License
- If cannot get approval for Prefab, *may* move terminal to near 1394 Hampshire St. - James Rolph Jr. Playground – do MOU with Rec & Park to use restroom in park; overhead wires in place

#### Alternatives if Prefab not approved: move terminal, e.g. to:

1. 44<sup>th</sup> / Noriega: License for Operator Restroom at Pete's Unocal 76 Station at 44<sup>th</sup> & Noriega (4 blocks)



 48<sup>th</sup> / Judah or Taraval: Permanent Operator Restrooms: end of N-Judah Line – 5 blocks; end of L-Taraval Line – 8 blocks (at 46<sup>th</sup> / Wawona)
