BRIEF DESCRIPTION: Approval of the Municipal Transportation Agency FY2006 Budget, as amended, totaling \$609,870,800.

SUMMARY:

- The MTA Board of Directors adopted a budget for FY2006 on February 28, 2005 based on the best information available at the time.
- On May 10th, the Controller's Office projected that the MTA will receive an additional \$6.6 million in General Fund support for FY2006 over the amount upon which the adopted budget was based.
- The MTA crafted an Alternative Balancing Plan that reduces the increases in parking fines and parking meter rates, eliminates the increases in senior, disabled and youth cash fares,
- The MTA is also proposing to eliminate the increase in the monthly adult Fast Pass rate.
- The legislation required to implement the Alternative Balancing Plan as it relates to parking fines and parking meter rates was passed on first reading by the Board of Supervisors.
- After the MTA Board's approval of the budget the Director has made technical changes and adjustments to the FY2006 Budget, including: changes in the cost of fringe benefits arising from the elimination of operator positions, changes reflecting updated projections from the Health Service System, and changes to reflect the MTA's tentative agreement with Local 1414.
- The MTA is continuing to work on developing long term financial solutions to diversify revenue sources, including dedicated fees and taxes.

EXPLANATION:

Background

Pursuant to Charter Section 8A.106, the MTA Board of Directors adopted a budget for FY2006 on February 28, 2005. This budget was the culmination of work that began in October 2004 and was based on the best information available at the time from the Controller's Office. The February 28, 2005 budget included plans to resolve a \$57.3 million deficit. The deficit was mainly due to increased salaries and benefits, higher fuel costs, and not implementing FY2005 planned service cuts.

The MTA took a "shared approach" in resolving the budget deficit by increasing parking fines, permit fees, garage and meter rates, the adult cash fare by 25 cents, senior/disabled/youth cash fares by 15 cents, reducing service, and implementing schedule efficiencies. The budget also includes using preventive maintenance funds and deferring capital projects.

Internally, as part of the FY2005 budget, the MTA initiated several measures to reduce expenditures including a hiring freeze and restricting the use overtime to fill runs. These measures, while necessary for the current fiscal year, had an impact on service.

Current Status

The budget initially approved by the MTA Board was based to some extent on citywide revenue projections prepared by the Controller's Office. On Tuesday, May 10, 2005, the Controller's Office informed the MTA that increases in real estate transfer tax revenues received during the current fiscal year caused the Controller to increase his projection of General Fund revenue to the MTA for FY2006 by \$6.6 million. This additional General Fund money comes from the \$30 million in additional real estate transfer tax revenue resulting from the City's robust real estate market.1

On May 12, 2005, the Board of Supervisors' Budget and Finance Committee considered four ordinances sponsored by the MTA and necessary to implement the MTA's budget which proposed increases to contractor and residential parking permit fees, parking fines, and parking meter rates. Several members of the Board of Supervisors had expressed reservations about the MTA's proposed parking fine and parking meter increases. In light of these views, the MTA crafted an Alternative Balancing Plan to respond to the Board of Supervisors' concerns. This plan was structured to reduce the magnitude of the proposed increases in parking fines and parking meter rates. The legislation required to implement the Alternative Balancing Plan was

¹ The Controller's Office also identified a net additional \$2.69 million in General Fund support for the current FY2005 from additional real estate transfer tax revenue received by the City. Since the MTA's total revenue from fare, parking fines, and parking meters is below the anticipated amounts approved in the FY2005 budget, the total revenue to the agency and planned expenditures in FY2005 will not exceed the total expenditures approved by the MTA Board in the FY2005 budget. As a result, no further MTA Board approval is necessary to expend this additional revenue.

amended in committee and recommended for adoption by the Board of Supervisors' Budget and Finance Committee. The full Board of Supervisors approved the legislation on first reading at its meeting of May 24. The second reading is anticipated to occur on June 7th.

Alternative Balancing Plan

The following Alternative Balancing Plan was presented to the Board of Supervisors on Tuesday, May 24, 2005:

Fiscal Year 2005-2006

Reduction of Fare Increases

Eliminate increase in cash fares for Seniors, Disabled & Youth \$0.8 Million

Reduction of Parking Fine Increases

Reduce increase in overtime parking meter violations in Neighborhood Commercial Districts from \$15 to \$5, and in Downtown from \$15 to \$10.

\$1.5 Million

Reduction in Parking Meter Rates

Reduce Parking Meter Rate Increase in Neighborhood Commercial Districts from the proposed \$1.00 per hour to \$0.50 per hour.

\$3.1 Million

Service Restorations

Continuation of services and positions restored in 2005

\$1.2 million

Total of FY 2005-2006 Revenue Reductions \$6.6 Million

The legislation implementing the parking meter rate increases and parking fine increases, consistent with the Alternative Balancing Plan, is included as Attachment A.

Reducing the planned increases in parking fines and parking meter rates will use \$4.6 million of the \$6.6 million in additional General Fund revenue for FY2006.

Eliminating the proposed increase in senior, disabled and youth cash fares will use \$0.8 million from the \$6.6 million in additional General Fund revenue.

Finally, the remaining additional revenue of \$1.2 million will be used in FY2006 to continue service that was restored in FY2005 as well as restoring service critical positions as a result of lifting the self-imposed hiring freeze.

Potential State Revenue

On Wednesday, May 11, the Governor announced that, as part of his FY06 budget for the State of California, Prop 42, gas tax revenue funds will be released to local jurisdictions. Should the Governor's budget be approved by the legislature, the MTA would receive \$5.9 million of these revenues. As a result of these potential state revenues, the MTA proposes eliminating the increase in the monthly adult Fast Pass. As the Controller has indicated that he will certify any additional state revenue, the MTA is confident that it will be able to allocate \$3.1 million to support the elimination of the increase to the monthly Fast Pass.

With the addition of the \$3.1 million allocated for the elimination of the increase to the monthly Fast Pass, the Alternative Balancing Plan would total \$9.7 million.

At the Budget and Finance Committee, the Budget Analyst for the Board of Supervisors presented a line item review of the proposed budget and recommendations for an additional \$2.8 million in savings. The Budget Analyst's recommendations are currently being reviewed and have not been included as part of the Alternative Balancing Plan.

The MTA FY2006 Budget will be heard at the Budget and Finance Committee meeting on June 2, 2005. Charter Section 8A.106 requires the Board of Supervisors to act on the MTA's budget no later than August 1st or it goes into effect by operation of law. The Board of Supervisors cannot modify the budget but can reject the budget by a two-thirds' vote.

The MTA is continuing to work on developing long term financial solutions to diversify revenue sources, including dedicated fees and taxes. Examples include a dedicated sales tax for transit, environmental vehicle impact fee, vehicle registration fee, increasing the parking tax rate, and a downtown assessment fee. The MTA has also initiated financial, management and operational audits to ensure efficiencies and reduce expenditures.

Technical Adjustments

Since approval of the MTA FY2006 budget on February 28, 2005, many technical adjustments have been made to more accurately reflect the changes in proposed service levels and the impact of citywide costs related to mandatory fringe benefits and cost of living adjustments. When submitted to the Controller's and Mayor's Offices on March 1, 2005, the total MTA budget was \$605.6 million, prior to adjustments for intra-fund transfers. After all of the technical adjustments for Mandatory Fringe Benefits and Cost of Living adjustments, the MTA FY2006 budget submitted by the Mayor's Office to the Board of Supervisors totaled \$609.9 million, prior to adjustment for intra-fund transfers.

These technical adjustments were primarily attributable to:

- Adjustment to Mandatory Fringe Benefits which represented a reduction of \$2.3 million; and
- An additional \$0.6 million in salary adjustments to fund the Cost of Living Adjustment resulting from the recently negotiated Collective Bargaining Agreement between the MTA and the Machinists Union (Local 1414); and

• Additional minor adjustments to Mandatory Fringe Benefits, also attributable to the recent agreement with Local 1414.

Recommendation

Staff requests that the MTA Board of Directors approve the amended FY2006 MTA Budget.

WHEREAS, Pursuant to Charter Section 8A.106, the MTA Board of Directors adopted a budget for FY2006 on February 28, 2005, based on the best information available at the time; and

WHEREAS, The approved FY2006 budget was dependent on four revenue measures which required approval by the Board of Supervisors including increases in parking fines and parking meter rates; and

WHEREAS, On Tuesday, May 10, 2005, the Controller's Office informed the MTA that increases in real estate transfer tax revenues during the current fiscal year caused an increase in projected General Fund revenue to the MTA of \$6.6 million; and

WHEREAS, On Wednesday, May 11th, the Governor of the State of California in his May revised budget announced the release of Proposition 42 money to local jurisdictions; and

WHEREAS, The City and County of San Francisco would receive \$5.9 million in Prop. 42 monies for Municipal Transportation Agency; and,

WHEREAS, On Thursday, May 12, 2005, the Board of Supervisors' Budget and Finance Committee amended two ordinances relating to parking fines and parking meter rates and forwarded the amended ordinances to the full Board of Supervisors with modifications that reduced the new revenue they are projected to generate for the MTA by \$4.6 million (see Attachment A); and

WHEREAS, The MTA proposed an Alternative Balancing Plan to allocate the additional \$6.6. million in General Fund revenue anticipated for FY2006; and

WHEREAS, If the two amended ordinances relating to parking fines and parking meter rates are approved by the Board of Supervisors, \$4.6 million of the additional General Fund revenue to the MTA will be needed to replace the lost revenue; and

WHEREAS, The MTA is now proposing to eliminate the planned increase in senior, disabled, and youth cash fares by allocating \$0.8 million of the additional General Fund revenue

to replace the revenue anticipated from this planned increase; and

WHEREAS, The MTA is now proposing to eliminate the planned increase in the monthly adult Fast Pass by allocating \$3.1 million of the Prop 42 gas tax revenues to replace the revenue anticipated from this planned increase; and

WHEREAS, The remaining \$1.2 million in additional revenue will be used in FY2006 to continue service which will be restored in FY2005 as well as restoring service critical positions as a result of lifting the self-imposed hiring freeze; and

WHEREAS, Technical changes and adjustments were made to the FY2006 MTA Budget after approval by the MTA Board of Directors on February 28, 2005, to accurately reflect the changes in proposed service levels and the impact of City-wide costs related to mandatory fringe benefits and cost of living adjustments resulting in a total FY2006 MTA budget of \$603.3 million; and

WHEREAS, The FY2006 revised budget request for the MTA is being prepared in accordance with City Charter Section 8A.106; and

WHEREAS, Charter Section 8A.106(b) requires the MTA to certify that the budget is adequate in all respects to make substantial progress towards meeting the goals, objectives, and performance standards established pursuant to Section 8A.103 for the fiscal year covered by the budget; and

WHEREAS, The MTA is proposing Municipal Railway fare changes, which would take effect on or before September 1, 2005, and are itemized in Attachment B to the calendar item, as a component of the MTA's FY2006 Budget as provided under City Charter Section 8A.108; now therefore be it

RESOLVED, That in accordance with the requirements of Charter Section 8A.106(b), the MTA certifies that the FY2006 MTA Budget as amended is adequate in all respects to make substantial progress towards meeting the goals, objectives, and performance standards established pursuant to Section 8A.103 for FY2006 contingent upon approval by the Board of Supervisors of the proposed increases in parking fines and parking meter rates and residential parking and contractor permit fees; and be it further

RESOLVED, That the MTA Board of Directors approves the Alternative Balancing Plan for FY 2006 by allocating \$4.6 million from additional General Fund revenue to replace the revenues lost as a result of reducing parking fine increase and parking meter rates in Parking Meter Area Number Three, \$0.8 million from additional General Fund revenue as a result of the elimination of the proposed increase in senior, disabled and your cash fares, \$3.1 million from Prop 42 revenues as a result of the elimination of the proposed increase to the monthly adult Fast Pass; and \$1.2 million from additional General Fund revenue to continue service which was restored in FY2005 as well as restoring service critical positions as a result of lifting the self-imposed hiring freeze for a total allocation of \$9.7 million; and be it further

RESOLVED, That the MTA Board of Directors approves the MTA's FY2006 Budget, as amended, in the amount of \$609,870,800; and be it further

RESOLVED, That the Director of Transportation is hereby authorized to make any necessary technical and clerical corrections to the approved budget of the MTA and to allocate additional revenues and/or City and County discretionary revenues in order to fund additional adjustments to the operating budget, provided that the Director shall return to the MTA Board of Directors for approval of technical or clerical corrections that, in aggregate, exceed a five percent increase of the total MTA FY2006 Budget.

Ordinance amending the San Francisco Traffic Code by amending Section 203.1 to increase the rate for parking meters in Parking Meter Area Number One to three dollars (\$3.00) an hour, by amending Section 203.2 and 203.4 to increase the rate for parking meters in Parking Meter Areas Numbers Two and Four to two dollars and fifty cents (\$2.50) an hour, and by amending Section 203.3 to increase the rate for parking meters in Parking Meter Area Number Three to two dollars and fifty cents (\$2.001.50) an hour.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Traffic Code is hereby amended by amending Sections 203.1, 203.2, 203.3, and 203.4, to read as follows:

SEC. 203.1. PARKING METER RATES--PARKING METER AREA

NUMBER ONE.

The rates for parking meters in Parking Meter Area Number One shall be three dollars an hour as follows:

(a) A five-cent piece (nickel) shall allow a parking time period of one and one-half-minutes following the deposit of such coin, and such deposit of five cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended; or

(b)	A ten-cent pie	ece (dime) shall ali	ow a parking tin	ne period of three	e minutes following	g the deposit of suc	h coin, and
such deposit o	f ten-cent pieces	s may be repeated	for a like period	of time until the	maximum time of t	the parking meter h	as been

- (c) A twenty five cent piece (quarter) shall allow a parking time period of seven and one half minutes following the deposit of such coin, and such deposit of quarters may be repeated for a like period of time until the maximum time of the parking meter has been expended.
- (d) The maximum time period permitted for parking at any parking meter, whether operational or broken, on the posted days and during the posted hours of its operation shall correspond to the time designated on the parking meter.

SEC. 203.2. PARKING METER RATES--PARKING METER AREA NUMBER TWO.

The rates for parking meters in Parking Meter Area Number Two shall be two dollars and fifty cents an hour. as follows:

- (a) A five-cent piece (nickel) shall allow a parking time period of two minutes following the deposit of such coin, and such deposit of five-cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended; or
- (b) A ten cent piece (dime) shall allow a parking time period of two minutes following the deposit of such coin, and such deposit of ten cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended; or

— (c) A twenty five cent piece (quarter) shall allow a parking time period of ten minutes following the deposit of such coin,
and such deposit of quarters may be repeated for a like period of time until the maximum time of the parking meter has been
expended.

— (d) The maximum time period permitted for parking at any parking meter, whether operational or broken, on the posted days and during the posted hours of its operation shall correspond to the maximum time designated on the parking meter.

SEC. 203.3. PARKING METER RATES--PARKING METER AREA NUMBER THREE.

The rates for parking meters in Parking Meter Area Number Three shall be *as follows:*two dollarsone dollar and fifty cents *an hour.*

- (a) A five cent piece (nickel) shall allow a parking time period of three minutes following the deposit of such coin, and such deposit of five cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended; or
- (b) A ten cent piece (dime) shall allow a parking time period of six minutes following the deposit of such coin, and such deposit of ten cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended; or
- (c) A twenty five cent piece (quarter) shall allow a parking time period of fifteen minutes following the deposit of such coin, and such deposit of twenty five cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended.

- (d) The maximum time period permitted for parking at any parking meter, whether operational or broken, on
the posted days and during the posted hours of its operation shall correspond to the time designated on the parking
meter.
SEC. 203.4. PARKING METER RATESPARKING METER AREA NUMBER FOUR. The rates for parking meters in
Parking Meter Area Number Four shall be as follows: two dollars and fifty cents an hour.
(a) A five-cent piece (nickel) shall allow a parking time period of two minutes following the deposit of such coin, and
such deposit of five cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been
expended; or
— (b) A ten cent piece (dime) shall allow a parking time period of four minutes following the deposit of such coin, and such
deposit of ten cent pieces may be repeated for a like period of time until the maximum time of the parking meter has been expended;
or
— (c) A twenty five cent piece (quarter) shall allow a parking time period of ten minutes following the deposit of such coin,
and such deposit of quarters may be repeated for a like period of time until the maximum time of the parking meter has been
expended.
- (d) The maximum time period permitted for parking at any parking meter, whether operational or broken, on
the posted days and during the posted hours of its operation shall correspond to the time designated on the parking
meter.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Traffic Code is hereby amended by amending Section 132, to read as follows:

SEC. 132. PENALTY SCHEDULE.
