RESOLUTION NO. 2008-XX

WHEREAS, the Taxi Commission currently has requiring medallion holders to drive their own taxicab vehicles when complying with the Proposition K driving requirement; and

WHEREAS, this Rule was discussed at the Rules Subcommittee of the Taxi Commission; and

WHEREAS, the Taxi Commission wishes to delete Rule 4.A. 10/amend Rule 4.A. 10 as follows; and

Unless their taxicab is out of service, a/ll Medallion Holders must drive their own medallion number taxicab *vehicle* when complying with the full time driving requirement provisions of MPC § 1081(f), *unless that vehicle is unavailable*.

WHEREAS, to ensure that medallion holders can receive paperwork from the Taxi Commission and keep their addresses properly updated, the Taxi Commission wishes to add Rule 4.A.13 as follows; and

Every Medallion Holder shall give written notice to the Taxi Commission within ten (10) days of any change of residence address, and shall accept mail at the address provided to the Commission. A post office box is not permitted. Every Medallion Holder designates his or her Color Scheme as the agent for service of process. Failure or refusal of a Color Scheme to accept service of process, or claims of nonreceipt, shall not relieve a Medallion Holder of the burden of response.

THEREFORE BE IT RESOLVED, that the Taxi Commission adopts the amendments described above.

RESOLUTION NO. 2008-XX

WHEREAS, the Taxi Commission currently has a rule requiring notification to the Taxi Commission by medallion holders when they will be not be driving; and

WHEREAS, this Rule was discussed at the Rules Subcommittee of the Taxi Commission; and

WHEREAS, the Taxi Commission wishes to amend Rule 4.A.11 as follows; and

Except for emergencies, every "Post K" Medallion Holder must submit a written notification to the Taxi Detail-Commission if they will not be driving his or her medallion will not be operated for a period of thirty (30) consecutive days or more. Notifications must be received within two (2) business days prior to the start of the period and shall include both the reason for the absence non-operation and the anticipated date of return to active driving operation. In the case of emergencies, notice may be received two (2) days after. Every Medallion Holder shall provide his order color scheme with emergency contact information if he or she plans to be residing out of the country or is otherwise unavailable for more than thirty (30) consecutive days. Notifications must be received within two (2) business days prior to the start of the period.

WHEREAS, to ensure that medallion holders can receive paperwork from the Taxi Commission and keep their addresses properly updated, the Taxi Commission wishes to add Rule 4.A.13 as follows; and

Every Medallion Holder shall give written notice to the Taxi Commission within ten (10) days of any change of residence address, and shall accept mail at the address provided to the Commission. A post office box is not permitted. Every Medallion Holder designates his or her Color Scheme as the agent for service of process. Failure or refusal of a Color Scheme to

accept service of process, or claims of nonreceipt, shall not relieve a Medallion Holder of the burden of response.

THEREFORE BE IT RESOLVED, that the Taxi Commission adopts the amendments described above.
