- **1. Minutes:** PSAC approved the November minutes.
- **2. SFPD Traffic Company: Capt. Al Casciato:** Discussed enforcement progress by motor cycle company. Looking forward to handheld computers which may help with the breakdown of data. Will submit latest data for our comments.
- **3. Pedestrain Safety Task Force Recommendations: Tim Papandreou, SFMTA:** Inter agency coordination is improving. Draft Report coming out soon and he reviewed their high priority items. **PSAC Comments:** also wanted to see: Community Court for feasibility study, bicycle ambassador program and more streets to park conversions.
- **4. Community Courts: Richard:** Presented: Should be modeled on DA program for minor offenses. **PSAC voted to:** Request that the SFMTA explore the feasibility of Community Court for pedestrian, bicycle and skate board etc. offenses; including: scope, staffing and funding issues.
- **5. SFMTA Staff Report: Luis: Presented:** Five Year \$30 Million Capital Improvement list for available and hopeful funds. Still working on most recent questions on push buttons. **PSAC Comments:** a) The large America's Cup projects will take time for design and PSAC and community review; b) Where is the funding for Count down signals? (in Streets budget); c) When will count down projects be completed? Who sets priorities for these projects? **Public Comment: Ed Mason:** Why are Sunday Streets shown as Capital project? Why is the total cost so high, combing bicycle and pedestrian amounts.
- **6. JFK Bike Track: Luis and John L:** SFMTA met with disability community and will: widen buffers to four feet minimum; provide six more curb ramps and make blue zones more visible. This has support of Mayors Disability Council. **PSAC Comments:** a) Prospect Park in Brooklyn also has bicycle speed bumps and more warning signs. b) PSAC and other ped groups have

to be involved earlier. c) PSAC will re-discuss the JFK bike track at the January meeting.
