At the meeting of the Rules and Regulations Subcommittee of the Taxicab Commission on Monday, March 31, 2008 the following resolution was recommended:

### **RESOLUTION NO. 2008-XX**

AMENDING RULES 4.A.7, 4.B.1, 4.B.3, AND 5.G.2.a OF THE TAXICAB/RAMPED TAXI RULES AND REGULATIONS:

**WHEREAS**, the Rules and Regulations Subcommittee recommends deleting Rule 4.A.7 of the Taxicab/Ramped Taxi Rules and Regulations; and

WHEREAS, the Rules and Regulations Subcommittee recommends amending Rule 4.B.1 as follows:

4.B.1. All required insurance policies or certificates shall include the name of both the Medallion Holder and Color Scheme Holder names of those who appear on the Certificate of Title and Registration pursuant to Rule 4.B.3.

WHEREAS, the Rules and Regulations Subcommittee recommends amending Rule 4.B.3 as follows:

4.B.3. The primary vehicle used for the operation of the Medallion Holder's permit will be registered only in the name of the Medallion Holder or Color Scheme. The Certificate of Title and the Registration on all vehicles placed into service after the effective date of these regulations after April 8, 2008 must only be under the name of the Medallion Holder and/or Color Scheme. The Certificate of Title and the Registration may contain the name of a licensed taxi driver holding a valid lease which complies with Rule 4.C.1, if the name of the Medallion Holder and/or Color Scheme also appear thereto.

WHEREAS, the Rules and Regulations Subcommittee recommends amending Rule 5.G.2.a as follows:

- 5.G.2.a. At the time of the scheduled inspection of the taxicab vehicle, the Color Scheme Holder or their designee must submit the following:
- a. Valid or current State of California vehicle registration card which complies with Rule 4.B.3. The Certificate of Title and Registration on all vehicles placed into service after the effective date of these regulations must only be under the name of the Medallion Holder and/or Color Scheme

### Holder.

**THEREFORE BE IT RESOLVED,** that the Taxi Commission accepts the recommendations of the Rules and Regulations Subcommittee and adopts amendments described above.
