### Administration/Policy

- We have a new, temporary staff member, Monlia Wu, who will be performing clerical work and assisting us with the manual entry of paper records into our new database, which is almost finished.
- Rules & Regulations Subcommittee: The date is December 9, 2008 at 12:30 PM.
- Issuance of New Medallions: We have 31 medallions left to be issued. This includes medallions that were returned because of the deaths of particular medallion holders.
- New Gate and Meter Charges: Because the Board of Supervisors has thus far failed to take action on the Controller's recommendation, it is anticipated that the new gate and meter charges will automatically take effect on January 14, 2009. The Taxi Commission will print new rate cards and taxicabs will have to have the meters recalibrated for the new rates of \$3.35 flag drop, .50 cents per 1/5 of a mile, and .50 cents per minute for wait time.
- Safety Hearing: We will have a full safety hearing on January 13, 2009.
- Annual Report: Like all Commissions, the Taxi Commission is required to produce an annual report. I will produce the Commission's annual report and present it at either the February 10 or the February 24, 2009 meeting of the Taxi Commission, and it will act as a final report of the Commission.
- ADA Policy: On or about January 1, 2009, the Commission will be sending out a standard letter to all Proposition K medallion holders regarding ADA modifications for Calendar Year 2008. We will be providing medallion holders with the opportunity to apply for an ADA modification for 2008 through January 31, 2009. We will also begin responding individually to each person who has submitted a request for modification.
- **Taxi stands:** the Commission invites interested parties in the public and the industry to submit suggestions for taxi stands. If you would like a taxi stand in your neighborhood, please email <a href="mainto:Tamara.Odisho@sfgov.org">Tamara.Odisho@sfgov.org</a>. Please note that downtown, the best place to obtain a taxi is at a hotel.
- Grants: I submitted current reimbursement requests for Yellow, National, Green, and Luxor Cab for the June 2007 grant cycle. I expect to hear any day regarding the approval of the March 2008 grant cycle. I still have \$4,000 CNG grants available.

### **Enforcement/Regulation**

• **Key Personnel Exemption:** Attached is the annual audit for the key personnel exemption. There were seven individuals that failed the audit. Everyone has submitted their forms for 2009, with the

- exception of Delta Cab and Fog City Cab, even after repeated reminders.
- **Drivers with No A-cards:** On November 15, 2008, John Henry Redmond caused an injury accident while operating a taxicab with no A-card.
- Renewing A-Cards: As of December 1, 2008, drivers can now renew their A-cards at the Treasurer's Office. Please note, drivers are required to list their current employer upon renewal. The Treasurer's Office has been informed not to accept individuals claiming to work at "Falcon Cab," "Sunshine Cab," and other fictitious cab companies. Additionally, only drivers with current A-cards may renew without attending taxi school. Any driver who attempts to renew an A-card which has been expired since May 1, 2008 will be considered to be operating without a permit.
- Administrative Hearings: Wei Chen Lee had the first part of his qualification hearing on November 7, 2008, but when he obtained counsel the second part was continued until December 12, 2008. Khaldoun Sukkar's hearing will be January 16, 2009. Philip Lo's hearing will likely be January 30, 2009. Kalesilassie Gebresilassie's hearing will most likely be January 9 or January 30, 2009.
- **Board of Appeals**: There are several upcoming hearings including <u>Ennazer</u> and <u>Rahimi</u>, and applicants that were denied medallions. The Taxi Commission submitted Respondent's Briefs in the <u>Ennazer</u> and <u>Rahimi</u> matters on December 4.
- Taxicabs Failing to Show Up for Inspection at Weights and Measures: Attached please find a list of <u>270</u> taxicab vehicles in the City and County of San Francisco which failed to show up for inspection at Weights and Measures. The Taxi Commission will have information from Weights and Measures on December 9, 2008 regarding the procedure for inspection appointments for these vehicles. Vehicles will be pulled from service if they do not show up for an appointment. Please note that taxicabs cannot just wait until the new rates take effect some of these cabs have not been inspected since 2006.
- Surprise Inspection at the Airport: The Taxi Commission, SFPD, Weights and Measures, and SFO personnel conducted an intra-agency inspection of 48 taxicab vehicles at SFO from 6 AM to 8 AM on Tuesday, December 2, 2008. Myself, Sgt, Reynolds, and Scott Leon participated. 3 vehicles were black-balled by SFO personnel because of problems with their tires or meters. Each one was sent to Weights and Measures for inspection, and two of them, Luxor # 2227 and Regents # 39, received notices of violation from Weights and Measures.

### MEMORANDUM

Re: 2007 Prop K Audit Results for Key Personnel

Date: 12/4/2008

The annual 2007 Prop K Audit for Key Personnel is now completed. I reviewed the FTDR for all color scheme managers who were designated as key personnel from the period of January 1, 2007 through December 31, 2007. To perform this audit, I inspected waybills and reviewed independent documentation corroborating that these managers actually performed their duties as specified in their designation forms. Such verification included payroll information, W2's, cancelled checks, corporate filings with the State EDD, and business contract agreements.

There were 29 total managers who turned in their Key Personnel Designation forms in 2007. However, not everyone performed enough hours as Key Personnel so they were subjected to the full driving requirement of 800 hours.

Attached is the 2007 Prop K Audit Report for Key Personnel. Out of the 29 managers, **seven** either completely failed their Prop K Audit or did not meet the partial completion of requirements. The following medallion holders *did not pass* the Key Personnel driving requirement as defined by MPC § 1081.5 and were admonished accordingly:

- 1. Peter Fox, #441 Arrow
- 2. Perseveranda Trinidad, #1098 Bay Cab: there is no evidence that this individual (1) has ever worked as a taxicab company manager and (2) has ever driven a taxicab vehicle in San Francisco
- 3. Hugh Fontaine, #902 DeSoto
- 4. Tom Stanghellini, #790 Luxor: waybills have been misplaced
- 5. Pam Martinez, #1220 Yellow: medallion holder admits she has not driven the requisite shifts
- 6. Johnson Akinbodunse, #1293 Yellow: medallion holder is very close to meeting the requirement
- 7. Martha Barakah, # 1068 Royal: This individual did not work as a manager and did not drive a taxicab, because she holds full-time employment as a Legal Secretary at Morrison Forrester law firm in Palo Alto.
