## **2008 Annual Safety Report:** Safety Initiatives, Statistics and Recommendations

Pursuant to Municipal Police Code § 1147.3(a), the Taxi Commission "shall hold an annual hearing to review (1) the compliance of taxicab permit holders with this Article and any regulations adopted pursuant to this Article; (2) the effectiveness of safety equipment and safety measures currently in effect; and (3) the need for further measures to reduce taxicab crime and to protect the public safety." The statute also empowers the Commission to direct the Executive Director to conduct a hearing on these subjects, write a report as a result, and to thereafter develop regulations if the director deems it necessary. Due to the Commission's few remaining weeks of existence, staff does not recommend that the Commission empower the Director to conduct a separate hearing beyond the January 13 hearing.

In view of our pending merger with the SFMTA, the Safety Hearing will not only review information in compliance with MPC § 1147.3(a), but highlight recommendations for future consideration by the SFMTA's newly created Division of Taxis and Accessible Services.

#### **Current Safety Equipment**

Owing to the adoption of new rules and regulations by the SFMTA, many of the outstanding issues with safety measures will be solved.

#### Shields

Shields have rarely, if ever, been used in San Francisco after the 2002 implementation of the safety cameras, and staff does not recommend shields as a viable safety measure. Safety cameras have supplanted shields in most modern cities for a variety of reasons.

#### Safety Cameras

One major safety measure that needs to be addressed is the new safety camera specifications. Attached please find two recent photographs. The first three pages were produced by the Daly City Police Department after a robbery took place in Daly City, in a San Francisco taxicab. As one can see from the pictures, the images are extremely blurry. Additionally, the date has not been set properly in the camera, so that the camera records a January 2000 date. The camera responsible for these images was a Silent Witness Fareview installed in 2002.

The next photograph is an image from a Verifeye camera in Toronto. The image is much clearer and sharper.

While staff anticipated rolling out the new camera specifications, at this time we recommend that the SFMTA address the camera specifications as one of the first items of business after the March deadline for the merger. A plan for ensuring that all companies comply with the specifications, and for testing the cameras, should be developed. Once again, staff will reiterate that all companies with Raywood cameras must replace these cameras. Companies are encouraged to think about the financial aspects of replacing the cameras.

#### **Major Safety Initiatives in 2008**

Attached please find quarterly activity reports from the Taxi Detail describing various types of enforcement efforts made during the four quarters of 2008 by the San Francisco Police Department. These activity reports describe enforcement which was taken against both taxi permit holders and limousines.

The Taxi Commission also conducted enforcement efforts of its own beyond the complaints for suspension and/or revocation described above. Those enforcement efforts were generally initiated after the Commission received complaints via the city's 311 system.

#### **Illegal Limousine Enforcement**

Thanks to substantial enforcement funding approved by the Commission, illegal limousine enforcement was a priority during 2008. In partnership with the California Public Utilities Commission, we conducted Operation Bandit I in December 2007, and Operation Bandit II occurred in June 2008. Operation Bandit III is already planned for an undisclosed future date.

Staff recommends that SFMTA conduct a focused effort on illegal transportation. Many administrative and legislative changes are necessary to fully resolve this problem. Fortunately there is already funding in the existing Taxi Commission budget which can be allocated to address illegal transportation. Public outreach, through a public awareness campaign, should be a major component of the effort.

#### Improved Service to AT&T and Candlestick Parks

Staff at the Taxi Commission and the Taxi Detail were very fortunate this year to work with the 49ers to improve service at Candlestick Park. The 49ers generously donated some tickets and other items to raffle off to drivers who participated in getting service out to the games. At the last game on December 28, 2008, the service was more successful than it has been in any prior year, with guest wait time for taxis dramatically reduced. Staff wishes to commend the 49ers for their partnership with the taxi industry, the Taxi Commission, and the Taxi Detail in making this happen.

In November 2008, an illegal transportation provider allegedly sexually assaulted a female after she took illegal transportation home from a 49ers game.

Unfortunately, service at AT&T Park remains a problem, due to ongoing administrative professional challenges. Staff recommends that SFMTA prioritize service at AT&T Park.

#### San Francisco Taxi Vehicle Safety and Compliance with Clean Air Taxi Program

The Taxi Commission also conducted a surprise inspection at SFO in December 2008 with staff from the San Francisco Airport and the San Francisco Police Department. This inspection revealed no outstanding safety violations with taxicab vehicles, and no evidence that individuals had switched vehicles without authorization. The Airport and the Commission were very pleased with the results of the inspection.

To improve taxi vehicle safety, staff recommends increasing the budget for the Ground Transportation Unit, to fund at least two more mechanics to assist with inspections, and at least one hydraulic lift so that GTU can check the undercarriage of vehicles. Or, the City could contract with a private inspection contractor that specializes in taxicab inspections. As part of the Clean Air Taxi Program, staff developed the Salvage Vehicle Program in consultation with GTU. Although controversial among company owners, staff at the Taxi Commission, SFPD, and GTU believe that the Salvage Vehicle Program results in safer vehicles for the public, because it gives GTU staff an opportunity to review a vehicle's physical history.

#### **Enhanced Accountability for Drivers and Taxi Permit Holders**

As in 2006 and 2007, Commission staff prioritized accountability for drivers and taxi permit holders. The Commission focuses on permit holders who represent a public safety risk, although other cases involving

• solely failure to adhere to the Proposition K Driving Requirement have survived for several years due to the nature of the appeals process. Staff highly recommends streamlining the appellate procedures to preserve due process, but also to protect public safety during the pendency of appeals. Staff is currently developing draft disciplinary, hearing, and appellate procedures for SFMTA's review and possible consideration.

Revocations finalized by the Commission and the Board of Appeals in 2008 include the following:

- Color schemes: KSJ, Grasshopper
- Taxi permit holders: Bashir Rahimi (pending at Board of Appeals), Azzam Ennazer (pending at Board of Appeals), Robert Friedman
- Drivers: William Hunger, Driss Elassali (pending at Board of Appeals)

The Commission also suspended or otherwise disciplined:

Yakub Mahmodoglu, Thomas Poole, Kingsley Njemanze, Douglas Wong, Jaspal Singh Walia (pending), Peter Witt, Jasvinder Bains, American Cab Co., and American Taxi Company.

From August to December 2008, staff assessed 19 separate admonishments to various drivers and initiated two revocation complaints based on facts alleged on 311. A report describing the amount and types of complaints from 311 will be ready by the time of the hearing on Tuesday.

#### Summary of Staff Recommendations to Enhance Safety

- Prioritize implementation of new safety camera specifications to protect drivers
- Implement a focused plan for illegal transportation providers
- Prioritize improving service at AT&T Park and continue existing successful Candlestick Park program
- Enhance vehicle inspection standards and provide GTU with additional funding, or use a private inspection contractor specializing in taxicab inspections
- Streamline ordinances governing permit appeals and develop new disciplinary and hearing procedures that will preserve due process but enhance accountability
