BRIEF DESCRIPTION:

Proposed parking rates and rate increases for the Civic Center Plaza Garage, Ellis O'Farrell Garage, Fifth & Mission Garage, Golden Gateway Garage, Japan Center Garage, Lombard Street Garage, Mission Bartlett Garage, Moscone Center Garage, North Beach Garage, Performing Arts Garage, Polk Bush Garage, Portsmouth Square Garage, S.F. General Hospital Medical Center Parking System, St. Mary's Square Garage, Sutter Stockton Garage, Union Square Garage, Vallejo Street Garage, 16th & Hoff Garage, 1660 Mission Street Garage, and the 7th and Harrison Parking Lot.

SUMMARY:

- The Municipal Transportation Agency ("MTA") Board of Directors has the authority to establish parking rates at 14 City parking facilities.
- The MTA Board, sitting *ex officio* as the Board of Directors of the Parking Authority for the City and County of San Francisco, has the authority to establish parking rates at the six parking facilities owned by the Parking Authority.
- Staff conducted a parking rate analysis to determine the effect of raising parking rates on garage revenues. The study indicated that modest annual rate increases would increase revenue and maintain transient customer base better than large rate increases.
- Using FY 2006 as a baseline, Staff projects that in FY2007, the proposed increased parking rates will generate \$1,831,898 additional net revenue and parking taxes to the MTA, \$491,432 additional net revenue to the Recreation and Park Department and another \$351,571 additional revenue to the City General Fund in parking taxes.
- The MTA Board will act on the Parking Authority garages as *ex officio* members of the Parking Authority Board of Directors
- The MTA Board will act on the City-owned garages as part of FY07 budget.

EXPLANATION:

Background:

Pursuant to the San Francisco Charter, the MTA Board of Directors has the authority to establish parking rates at the 14 City parking facilities. Sitting *ex officio* as the Board of Directors of the Parking Authority, the MTA Board has the authority to establish rates at the six Parking Authority parking facilities.

Last year, the MTA Board held public hearings and adopted proposed parking rate increases for City and Parking Authority garages as part of the FY06 budget. At that time, Parking Authority staff recommended that the MTA implement modest annual increases in parking rates, rather than large rate increases. That recommendation was based on extensive analysis by staff on the impacts of parking rate increases at each garage.

Transient parkers are the predominant users of City and Parking Authority facilities. A principal concern with raising parking rates is the possible reduction in transient patron volume that could result in lower long-term revenue growth. Staff analyzed the impacts of hourly rate increases ranging from twenty-five cents to one dollar for each City and Parking Authority garage, and determined that modest annual rate increases provided more revenue over the long term with lower loss of transient patrons.

Staff recommended an incremental approach to rate increases that would:

- generate more revenue
- minimize the reduction of transient parkers and
- preserve the MTA's ability to implement future rate increases as market conditions allow.

Staff's projected revenues for FY06 through FY10 are:

Since last year's FY06 rates were implemented, the MTA's incremental approach has resulted in an overall increase in net revenues, while maintaining transient parker volume.

Staff anticipates that net garage revenues for FY06 will exceed the \$2,839,330 revenue target by \$536,185, a 19 percent increase over the goal. Resulting reductions in transient volume are projected to be 3.8 percent or 293,436, as anticipated in the staff study.

FY07 Proposal

Pursuant to Section 10 of the MTA Rules of Order and Charter Section 16.112, duly noticed public hearings concerning parking garage rates were held on February 7 and February 21, 2006.

At the February 21, 2006 meeting, staff presented three options for the Board's consideration. At the meeting the Board requested additional information on each garage. Summary information for each garage is provided in a memorandum that supplements this staff report (Attachment 3).

Summary of Rate Changes:

All three options include increasing monthly rates, implementing new rates and expanding motorcycle accommodations. All three options include identical rates for each of these three categories.

The transient parking rate is the only difference between the three options.

Option 1:

This option includes an increase in transient parking rates at all garages, except at the Ellis-O'Farrell, Fifth and Mission, Sutter-Stockton, North Beach and Vallejo Street garages.

The benefit of keeping the first two hour charges the same at the Union Square, Ellis-O'Farrell, Sutter-Stockton and Fifth and Mission garages, is because these four garages work together to reduce traffic in the downtown area by redirecting traffic from a full garage to another downtown garage. This cooperative effort among these four garages has prevented traffic from backing up outside garage entrances or cars circling the block in congested shopping areas during peak periods. When a sustained queue occurs, garage personnel redirect cars to a nearby garage.

Keeping the short-term rates at these garages the same also has important customer benefits. Patrons expect to pay the same short-term rate at any of these four garages, which is good for marketing and repeat business.

Last year, following the implementation of the FY06 rate increase, Sutter-Stockton Garage saw a loss in transient volume by over 86,460 vehicles. Because of this unanticipated loss in transient volume, staff does not recommend increasing rates at the Sutter-Stockton Garage this year.

In order to continue the benefit of all four downtown garages charging the same rate, this option includes keeping the first two hour rates at the Union Square, Ellis O'Farrell and Fifth & Mission garages at the FY06 rate.

The North Beach and Vallejo Street garages experienced a combined reduction in transient volume of 3.6 percent last year despite the fact that the rates at these two garages were not increased. Option 1 includes maintaining the current rates at the North Beach and Vallejo Street garages for FY07.

Staff projects that Option 1 would result in increased revenues in the amount of \$1,431,536 to the MTA, \$446,399 to the Recreation and Park Department and \$282,312 to the City's General Fund with no impact on the total transient volume. This option provides the greatest flexibility for the MTA to increase rates next year.

Option 2:

This option proposes keeping the Sutter-Stockton Garage, the North Beach Garage and the Vallejo Street Garage the same because of the reasons discussed in Option 1. Under this option, the first-hour rate at the Union Square, Ellis-O'Farrell and Fifth and Mission garages would increase. These increases will forgo the benefits of keeping the first two hour charges the same as at the Sutter-Stockton Garage, but in return, this option will provide an additional \$400,362 in revenue to the MTA, \$45,033 to the Recreation and Park Department and \$69,259 to the City's General Fund over Option 1.

Under Option 2, staff projects an increase in revenue by \$1,831,898 at the expense of a decrease in total transient volume by over 80,000 vehicles. As compared to Option 1, this option will provide less flexibility to increase rates next year.

Option 3:

This option proposes keeping the Sutter-Stockton, North Beach and the Vallejo Street garages the same because of the reasons discussed in Option 1. Under this option, the Ellis-O'Farrell Garage and the Fifth and Mission Garage rates would be increased by a larger amount than the increases proposed in Option 2. This would result in a larger variance in rates at the downtown garages which could have a greater impact on traffic congestion in the area.

Under Option 3, staff projects increased revenues in the amount of \$2,331,896 at the expense of a decrease in total transient volume by over 160,000 vehicles. This option will provide the least flexibility to increase rates next year.

Proposal:

Based upon the comments heard at the February 7 and 21 meetings, staff proposes Option 2. Option 2 rates are detailed in the attached exhibits.

Option 2 will generate revenue for the MTA, the Recreation and Park Department and the City's General Fund (through additional parking tax) while minimizing the long-term impact that rate changes have on transient volume. Under this option most City-owned and Parking Authority-owned garages, including downtown, financial and neighborhood garages, will have some of their rates increased. The Sutter-Stockton, North Beach and Vallejo Street garages cannot sustain a rate increase without the possibility of a substantial negative impact on transient volume, therefore, staff does not recommend increases at these garages this year.

Option 2 will result in a lower first two hour rate at one of the four downtown garages (Sutter-Stockton). The new rates at the remaining three garages, Union Square, Ellis-O'Farrell and Fifth and Mission, will continue to be the same for the first two hour rate categories. As discussed under Option 1, there is a benefit in having the garage rates at these four garages the same, however staff believes that the benefit of reducing congestion will not be impacted to a great degree. In addition when the downtown garages are near or at capacity, staff anticipates that some vehicles will go to the Sutter-Stockton garage, which will assist that garage in increasing transient volume.

Staff projects that the proposed parking rates will generate \$1,831,898 additional net revenue to the MTA for FY 2007. The proposed rates will also provide \$491,432 additional net revenue to the Recreation and Park Department and \$352,571 in additional parking taxes to the City's General Fund. Staff proposes to implement the rate changes for all garages as soon as possible but not later than April 1, 2006.

Pursuant to state law, the MTA Board must act separately on the City-owned and Parking Authority owned garage rate proposals. Sitting as *ex officio* members of Parking Authority Board of Directors, the Board will adopt rate changes for the Lombard Street Garage, the Moscone Center Garage, the North Beach Garage, the Performing Arts Garage, the Polk Bush Garages, and the San Francisco General Hospital Medical Center Parking System.

Approval of the City-Owned garage rates is included as part of the resolution to approve the MTA's FY06 budget. The proposed parking rates are for the Civic Center Plaza Garage, the Ellis-O'Farrell Garage, the Fifth and Mission Garage, the Golden Gateway Garage, the 16th & Hoff Garage, the Japan Center Garage, the Mission-Bartlett Garage, the Portsmouth Square Garage, the St. Mary's Square Garage, the Sutter-Stockton Garage, the Union Square Garage, the Vallejo Street Garage, the 1660 Mission Street Garage, and the 7th & Harrison Parking Lot.

Recommendation:

Staff recommends that the MTA Board and the Parking Authority Board approve the proposed parking rates and rate increases, as set out in the rate schedules attached as exhibits. The rate schedules shown on the attached exhibits reflect Option 2.

WHEREAS, Staff proposes that the MTA Board and the Parking Authority Board adopt the parking rates shown in the rate schedules attached here as Exhibits; and,

WHEREAS, The Parking Authority Board of Directors has reviewed the proposed parking rates; now, therefore, be it

RESOLVED, That the Parking Authority Board of Directors approves the proposed parking rates in the attached Exhibits for the Lombard Street Garage, the Moscone Center Garage, the North Beach Garage, the Performing Arts Garage, the Polk Bush Garages, and the San Francisco General Hospital Medical Center Parking System, and authorizes the Director of the Parking Authority or his designee to implement the rates at each facility as soon as possible, but not later than April 1, 2006.
